

Declaration with consent for the processing of private data

General part and consent for data processing

To begin with, we thank you for your interest in participation in the Riga Aviation forum 2022 (Event).

To continue registration, you must give consent to the processing of your personal data based on 27.04.2016. Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals regarding the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) and based on this declaration.

When you start completing the application form (Form) for a measure, you give your consent to the processing of the data – if you do not wish to consent to the processing of the data in accordance with this privacy statement, please do not start completing the Form. Likewise, you certify that the information provided in the Form is true and you have all the rights to provide the specified information.

Purpose for processing your data

The data you provide will be processed exclusively for the purpose of registering and participating in the Event (communication, identification, etc.), as well as for the technical use of certain functions in home page: www.raf2022.lv that are accessible only to registered users. Also, the data can be used to provide announcements, news, information, questionnaires about the Event or the outlined topics.

Categories/types of data collected

The data collected corresponds to the Form information, i.e., to identify the data subject (minimum volume), as well as contact information.

Usage of photographic and video material taken at the Event

To comply with global data privacy laws, the organizers impose certain restrictions on the use of multimedia at its events (e.g., photography, video, audio, online streaming, and all future mediums). An attendee is permitted to use hand-held cameras and/or smart phones to take photographs and capture digital images for personal, non-commercial use, provided the photography is not disruptive. Photographs may not be published, sold, reproduced, transmitted, distributed or otherwise commercially exploited in any manner whatsoever.

Organizers may hire professional service providers (photo/video/streaming/audio) to document and display the event experience. Organizers may also use social media (e.g., Twitter) to: (i) post real-time photos and videos to its social media feeds; and (ii) display select submissions from those feeds on monitors throughout the event venue. Attendees and sponsors are encouraged to capture their event experiences and post their own social content from the event (text, photos, audio, video, streaming), provided it does not infringe upon the rights of any attendee, sponsor, third party, or Organizer. Such infringement would include, but is not limited to, defamation or infringement of intellectual property rights. In the event an attendee requires a release or permission to protect the rights of a third party, obtaining such a release or permission shall be the sole responsibility of the attendee.

By attending the event, you acknowledge and agree as follows: (a) Organizer may edit and use footage it captures at the event for marketing and promotional activities and for any other lawful purpose in the ordinary course of its business; and (b) due to the prevalence of mobile recording devices in today's world, Organizer disclaims all liability for the capture of your image in any multimedia format by other attendees at the event.

Processing, storage, transfer, revocation

You have the right at any time to reverse the processing of provided data, to specify the data etc. by sending an e-mail to info@db.lv. The specified contact e-mail may be changed.

The submission of data and consent to the processing of data is considered both - complete filling and submission of the Form, as well as its partial filling, namely, Form filling launch without completion.

The data shall be processed for a period of 24 months from the date of their submission. After the specified period, the collected data will be deleted. The period laid down for legitimate purposes may be extended by informing the data subject, thereby allowing the possibility of waiving further data processing.

The provisions of the declaration may be amended, including supplemented, considering the purposes, volumes, and processing deadlines of the data processing.
